

Subject: **APPROVAL FOR ADDENDUM OF INITIAL ENVIRONMENTAL EXAMINATION (IEE) FOR 25MW WIND POWER PROJECT**

Please refer your letter No. Nil dated 30th October 2019 on the subject noted above. Sindh EPA has decided to extend its approval for further Three (03) years under the provisions of Sindh Environmental Protection Act-2014 with subject to compliance of following conditions:

- i. Compliance of all the conditions laid down in previous IEE approval issued by this Agency vide letter No. EPA/2015/10/21/IEE/72 dated 28-11-2016 shall be ensured. However, this approval is only valid for M/s. Moro Power Company (Pvt.) Ltd located at Near Super Highway in Deh Kharyo at Jhampir, Nooriabad Road, district Thatta for the establishment of 25MW wind power project and proponent shall not extend his operation beyond the scope of proposed project activity. Any change in the approved project shall be communicated to Sindh EPA and shall be commenced after obtaining the approval.
- ii. The implementation report of all the mitigation measures and EMP laid down in the IEE report should be submitted to this office on quarterly basis for review. No violation of any Regulations, Rules, Instructions and Provision of Sindh Environmental Protection Act-2014 shall be made. It would be sole responsibility of the proponent and it encompasses all the plan i.e Tree Plantation, Waste Management, Traffic Management, Site Management Plans and Water Quality as well as Air Quality Monitoring Plans respectively. For this purpose, EMP should be strictly implemented. The proponent shall be responsible for adopting appropriate mitigation measures for controlling anticipated environmental issues.
- iii. The monitoring shall be carried out during the entire period of the Project activities and monitoring reports shall be submitted to Sindh EPA on *quarterly basis*. The Lab analysis report of Sindh EPA certified laboratory would only be acceptable.
- iv. All mitigation measures recommended in IEE report and Environmental Health and Safety Guidelines of International Finance Corporation (IFC) World Bank Group should be complied with, for achieving negligible impacts on physical, biological and socioeconomic resources of proposed project area, air emission and effluents generated must be comply permissible levels as per Sindh Environmental Quality Standards (SEQS), monitoring reports for compliance of SEQS will be submitted to Sindh EPA in accordance to self-monitoring and report Rules

- v. The proponent shall ensure the strict and efficient health and safety measures.
- vi. The benefits to the locals peoples will be offered under corporate social responsibility, policy, community development schemes will be decided and consultation with local community and may be facilitated by involving District/ Local Government Office.
- vii. Compensation will be provided to the inhabitant in case of loss of Agriculture Land, Crop and Property etc in accordance with the rates, data agreed upon. All conflicting issues regarding the compensation etc should be settled in advance prior to the start of activity.
- viii. That the proponent shall be exclusively responsible for information provided through report/ documents for its addendum in earlier approval issued by SEPA. In case of any misrepresentation/ concealment of facts then this approval shall stand cancelled without any notice.
- ix. That this approval is not valid for any Court Matter/ Land Dispute.
- x. SEPA can examine the conditions in respect of Environmental Approval is issued. In addition, this Agency have reserves the right to issue instruction for an independent environmental audit at any stage and stipulate additional conditions, if found necessary for the compliance of Sindh Environmental Protection Act-2014 and its Rules & Regulations made there under.
- xi. No violation of any Rules, Regulations and Provisions of Sindh Environmental Protection Act shall be made.
